20 NATURE OF THE ACTION

21 1. Agents and clients have been exiting the talent agency ICM Partners as recently
22 reported. Rather than focusing upon this concern, for months, ICM Partners has launched a
23 nuisance correspondence offensive against Resolution, the talent agency run by former CMT chief
24 Jeff Berg. ICM Partners seems to believe, unjustifiably, that Resolution is a reason for its woes
25 because of the happenstance that some of the agents who left ICM Partners now work for
26 Resolution. ICM Partners has sent a number of claim letters to Resolution gravely "reserving
27 rights" against Resolution regarding these agents and commissions. ICM Partners contends that
28 Resolution has to pay to ICM Partners commissions Resolution earns for some deals Resolution

1 either has negotiated or will negotiate through the agents who used to be ICM Partners employees.
2 All of ICM Partners' threats remain in limbo. By this action, Resolution seeks to finish what ICM
3 Partners started with its letter campaign, so that Resolution may continue to serve its clients'
4 interests without attracting claim letters from ICM Partners.

5 **FIRST CAUSE OF ACTION**

6 **(For Declaratory Relief Against All Defendants)**

7 2. Defendant International Creative Management Partners LLC d/b/a ICM Partners is,
8 and at all times mentioned in this complaint was, a limited liability company under the laws of
9 Delaware with its principal place of business in California.

10 3. Plaintiffs presently do not know the true names and capacities of defendants sued
11 herein as Does 1 through 10, inclusive. Plaintiff will seek leave of Court to amend this complaint
12 to allege said defendants' true names and capacities as soon as Plaintiff ascertains them.

13 4. At all times mentioned herein, each defendant was the agent, predecessor and/or
14 successor-in-interest of each and all of the other defendants, and in such capacity maintains that it
15 has a legal interest in the controversy alleged herein.

16 5. An actual controversy has arisen and now exists between Plaintiff and Defendants
17 concerning their respective rights and duties.

18 6. Defendants contend that Plaintiff must pay over to Defendants commissions earned
19 by Plaintiff on some deals that have been or will be negotiated on behalf of clients by former
20 employees of Defendants who are currently employed by Plaintiff.

21 7. Plaintiff contends it owes no duty to pay over to Defendants commissions earned
22 by Plaintiff on any matters negotiated on behalf of clients, whether through such employees or
23 otherwise.

24 8. Plaintiff desires a judicial determination of its rights and duties, and specifically a
25 declaration that it owes no duty whatsoever to Defendants with respect to commissions.

26 9. A judicial determination is necessary and appropriate at this time under the
27 circumstances in order that Plaintiff may ascertain its rights and duties and eliminate the nuisance
28 and burden of the intermittent flow of claim letters asserting commission controversies that are

1 never resolved.

2 **PRAYER FOR RELIEF**

3 WHEREFORE, Plaintiff prays for judgment against Defendants as follows:

- 4 1. Declaring that Plaintiff owes no duty whatsoever to Defendants with respect to
- 5 commissions.
- 6 2. Awarding Plaintiffs costs of suit incurred herein; and,
- 7 3. Awarding Plaintiffs all other and further relief that the Court deems just and proper.
