1 **THE PARTIES**

2 2. Plaintiff DIRECTV is a California limited liability company with its headquarters in El
3 Segundo, California. The sole member of DIRECTV, LLC is DIRECTV Holdings, LLC, a Delaware
4 limited liability company. Plaintiff DIRECTV provides digital television entertainment via satellite to
5 over 20 million subscribers in the United States.

6 3. Defendant AJA is a Delaware limited liability company with its principal place of
7 business in New York, New York. AJA is a U.S. affiliate of privately-owned Al Jazeera Media
8 Network, a Middle Eastern multinational multi-media corporation based in Qatar.

9 **JURISDICTION AND VENUE**

10 4. This Court has personal jurisdiction over Defendant AJA because AJA does business
11 within California, and because AJA has consented to jurisdiction in the Agreement, which provides that
12 “[t]he parties hereby agree that the jurisdiction of, or the venue of, any action brought by either party
13 shall be in a state or federal district court sitting in . . . Los Angeles, California and both parties hereby
14 agree to waive any right to contest such jurisdiction and venue.”

15 5. Venue is proper in this Court because the contract that is the subject of this lawsuit was
16 negotiated and drafted in El Segundo, California, and because, in the Agreement, AJA consented to
17 venue “in a state . . . court sitting in . . . Los Angeles, California”

18 **BACKGROUND FACTS**

19 6. DIRECTV provides digital subscription television services via satellite to over 20 million
20 subscribers nationwide. As part of the television programming services and other services DIRECTV
21 provides to its subscribers, DIRECTV distributes various television networks that are owned and
22 operated by third-party content providers, such as Defendant AJA.

23 7. On July 13, 2005, DIRECTV entered into an Affiliation Agreement with Current TV,

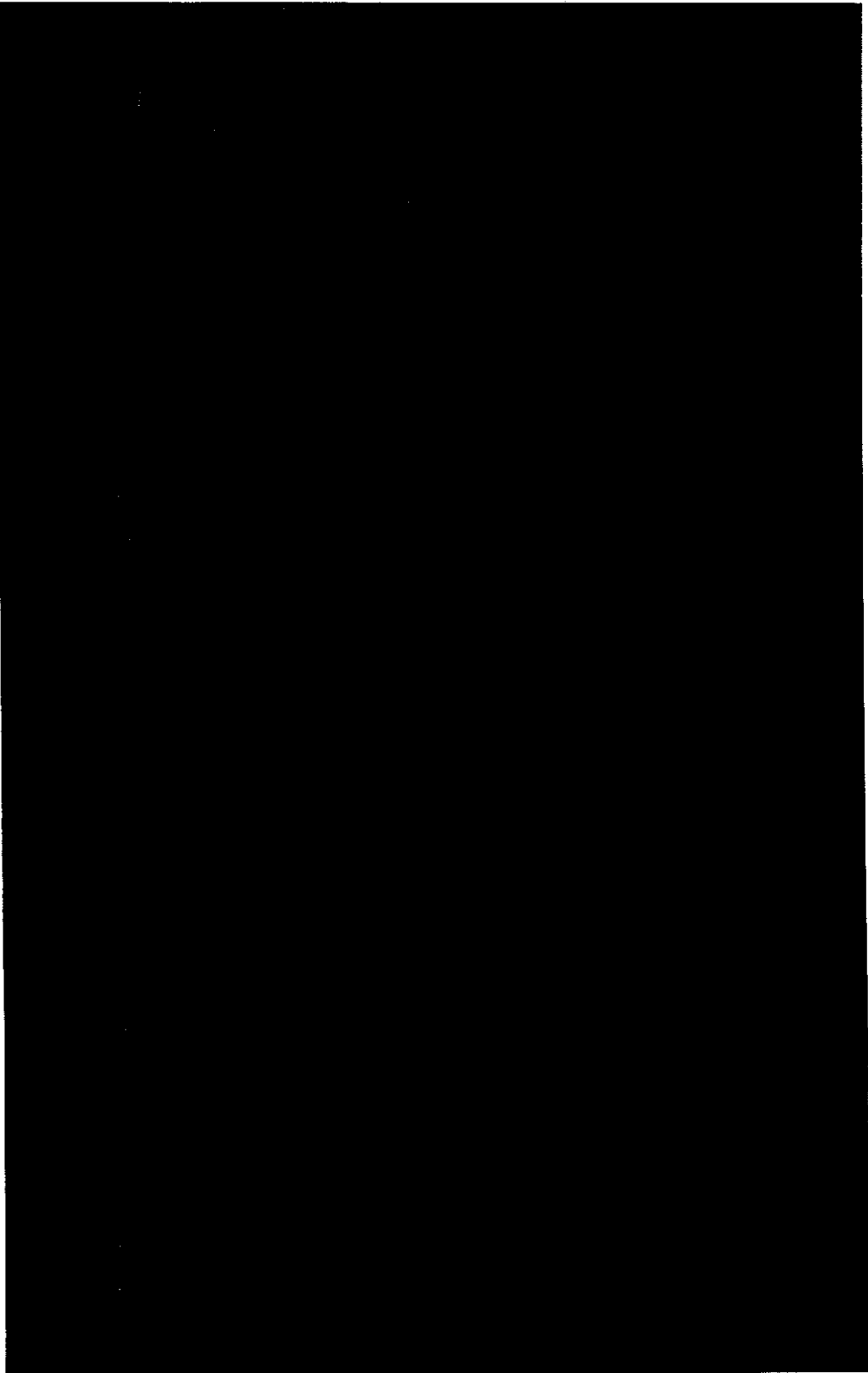


